- 3) The sealed bid should reach in this office by 2.00 PM on or before 06/11/2018 and it will be opened in the BMHRC Admin block-6. Bids received after due date / time will not be accepted. Bids send by E-mail / Fax will not be considered.
- 4) The vendor has to quote the rate of companies having WHO/GMP certificate only. Same may be asked from the concerned vendor anytime and has to be submitted within 7 days, failing to which the bid will be treated as invalid.
- 5) Shelf life of drugs-
 - a. Short-life items (which have a life-period of eighteen months or less) should not have passed $\frac{1}{4}$ the life at the time of supply.
 - b. In respect of items not covered by clause (a) above, items should not be older than one year from the date of manufacturing at the time of supply.

- 6) Vendor has to quote rate of one company only for a particular drug . In case the rates of multiple companies for one drug is quoted by vendor, the bid will be treated as invalid.
- 7) Bids must be hand-delivered and deposited at undersigned office on or before the deadline for submission of bids.
- 8) Bidders are responsible to ensure that their bid complies in full to the indicated requirements.
- 9) BMHRC reserves the right to reject any or all bids without assigning any reason thereof.
- 10)The bidder shall arrange for replacing the slow moving / non moving / expired drug. In case of non replacement of the items the cost of the items will be recovered from the running bills of vendor.
- 11)Offer will be valid for one year from the opening of the bid.
- 12)Kindly provide the bid as per attached format.
