The Bidder agency shall enclose the self attested copies of PAN Card, Registration Certificate of firm, GST Registration of firm alongwith their quotation in case of non submission of mentioned documents the submitted quotation/ offer of bidder would not be considered by BMHRC.

SCOPE OF REQUIREMENTS & GENERAL CONDITIONS :-

- 1) The installed machine would be exclusively used for Echocardiography Diagnostic Services at BMHRC Hospital only.
- 2) BMHRC would ensure compliance of **Pre-Conception and Pre-Natal Diagnostic Techniques (PCPNDT) Act** in the use of machine at the institute.
- 3) The equipment lessor agency shall be fully responsible for the comprehensive maintenance / servicing of equipments under normal mode of operating the machine by BMHRC to keep it in satisfactory running condition at the institute and any snags shall be rectified within 24 hrs of intimation by BMHRC. In case of any failure on the part of agency, pro rate payment may be deducted based on equipment downtime.
- 4) All the insurance charges, levies, taxes are considered as included in the quoted amount by the bidder.
- 5) In case of any dispute during the contract duration Director BMHRC shall be the sole arbitrator in case of adjudication and courts at Bhopal shall be having the legal jurisdiction.
- 6) The equipment offered by most responsive L-1 quoted bidder would be demonstrated before the Cardiology Department of BMHRC and subject to fulfilling of all the desired parameters & specifications as verified by BMHRC user department the equipment would be selected for installation.
